#### **HOMOEOPATHY: A BRIEF INTRODUCTION**

The Homoeopathic system of medicine is one of the fastest growing complementary/ alternative (CAM) medical systems in the world a system of medicine,



based on the principle of "treating like with like". Homoeopaths treat patients and not the diseases and take into account a range of physical, mental and lifestyle factors of patients for the selection of medicines. Hence, Homoeopathy is tailor made for individualized treatment. Homoeopathic medicines stimulate the body's own defense system and allow the body to heal itself. Such medicines are very safe, gentle and do not have toxic side effects. This system, which was first introduced in Germany and came to India in the early nineteenth century, has taken roots in the country and gained mass acceptance, as well as, official recognition. Homoeopathy is unique in that the preventive aspects are given as much importance as the curative. It is also cost-effective and safe.

It is a fact that no single medical system can manage all the health care needs of society and every system of medicine has its own areas of strength and weakness. The Allopathic system has effective treatment options in the management of acute infections, accidents and emergencies, surgical conditions, etc. The traditional Indian system of medicine (Ayurveda) is known for its efficacy in managing the life style diseases, etc. Similarly, Homoeopathy has its unique strength in the treatment for allergic disorders, respiratory complaints, gastro- intestinal problems, skin diseases, behavioral problems, etc.

Women and children constitute about 67% of India's population and their health is one of the most important public health issues confronting the country today. Despite all the efforts put in by various Governments, the health indices still display a grim healthcare situation in India. Of particular concern is the morbidity and mortality associated with childbirth in women and with infants and young children.


#### HOMOEOPATHY AND ALLOPATHY: THE CRUCIAL DIFFERENCE

The cardinal difference between Allopathy and Homoeopathy is in the dosage of the medicine employed in treatment. Through a process of *Potentization* or *Dynamization* (a combination of the successive processes of dilution and succussion), the drug loses its material substance and acquires 'potency'. The higher the dynamization, lower the amount of the crude material substance in the medicine

and higher the potency of the final product. In employing remedies according to the principle of Similia, the quantity of the dose is guided by the biological phenomena known as "Arndt-Shultz Law" which states that "Weak stimuli increase physiologic activity and very strong stimuli inhibit

or abolish activity." Needless to say, there is only one unique remedy which will be similar at one point of time. Hence Homoeopathy believes in the administration of a single medicine at a time.

Homoeopathic treatment of every individual is indeed a challenge which has to be taken up individually. The objective of a homoeopath is to alter or modify the disordered state of internal balance which will allow the individual to adapt well to the environment in the bio-psycho and social sphere. He also takes support of ancillary measures like diet, regime, nutrition, exercise and wherever needed and indicated is able to appreciate surgical measures.






After childbirth: healing of soft tissues, anemia, breast engorgement, deficient secretion
of milk, cracked nipples, constipation, retention of urine, painful urination, etc.



#### SPECIFIC AREAS OF STRENGTH IN INFANCY AND CHILDHOOD

- **Neonates and infancy**: constipation, diarrhea, colic, diaper rash, dentition troubles, eczema, common cold, etc.
- Childhood: acute infections, cough and cold, fevers, diarrhoea, vomiting, fears and phobias, temper tantrums, warts, tonsillitis, nocturnal enuresis, injuries, childhood asthma, constipation, urinary tract infections, behavioral disorders and learning disabilities, etc.



These complaints can be successfully treated in Primary Health Centers or homoeopathic Out Patient Departments (OPDs) of hospitals by trained homoeopathic practitioners.



#### **HEALTH STATUS OF WOMEN AND CHILDREN IN INDIA**


The health status of women and children in the country remains extremely unsatisfactory even after sixty years of Independence. Of particular concern are the morbidity and mortality associated with childbirth in women and also the high morbidity and mortality of infants and young children.





Considering that women and children constitute **66.7** % of the population, this is one of the most important public health issues confronting the country. In absolute terms too, the numbers are exceptionally large given that there are around 68.6 crores of women and children who are affected. The maternal mortality rate, i.e. the number of maternal deaths per 100,000 registered live births for India is 301.

The National Health Profile 2006 indicates that 45.9% of children under the age of 3 years are underweight and 38.4% of children are stunted. 79.1% of children in the age group of 6-35 months are anemic. The age specific mortality rate for children in the age group of 0-4 years is very high at 17%. It is estimated that under-nutrition and anaemia are contributory factors in over 50% of under 5 deaths. The major causes of infant mortality continue to be prematurity and low birth weight, poor intra- partum and newborn care, diarrhoeal diseases, acute respiratory infections and other infections. The neonatal mortality rate in India is 37 per 1000 live births, post-natal mortality rate is 21 per 1000 live births and infant mortality is as high as 58 per 1000 live births.





#### **NEED FOR NATIONAL CAMPAIGN**

In order to highlight the strengths of AYUSH systems, the Department of AYUSH decided to launch a number of national campaigns to focus on specific disease conditions. The National Campaign on Homoeopathy for Mother and Child Care was one of these campaigns. The National Campaign also aimed at sensitizing policy makers, medical professionals of other systems and the common man about potential role of Homoeopathy in treating mother and child health problems.

#### **GOVERNMENT INITIATIVES**

RNMENT INITIATIVES

The Government of India has over the years taken a number of initiatives to improve the health status of women and children. In order to effectively improve the health status of women and Children, Government of India during 1997-98 launched the Reproductive and Child Health (RCH) Program. The RCH Phase II which began in April 2005 focused on the reduction of maternal and child morbidity and mortality with emphasis on rural health care.



The National Health Policy (NHP) on AYUSH (Ayurveda, Yoga & Naturopathy, Unani, Siddha and Homoeopathy) envisages the promotion of good health and the expansion of health care through preventive, promotive and curative interventions through Indian systems of Medicine and Homoeopathy and the phased integration of these systems with modern medicine. The policy recognizes the fact that the Indian Systems of Medicine offer a wide range of treatment that are cost-effective and efficacious. Their inherent advantages such as accessibility, affordability and broad acceptance by the public have to be harnessed for the provision of preventive and curative health care. The AYUSH systems have inherent advantages such as natural plant-based products, low cost, absence of drug toxicity, etc. The holistic nature of these systems is another major advantage.



Recognizing the importance of health in the process of economic and social development, the Government of India launched the National Rural Health Mission (NRHM) in 2005 to provide accessible, affordable and quality health care to the rural population and especially the vulnerable sections of society. The health of women and children is high on the priorities of the NRHM with a reduction in child and maternal mortality and universal access to services related to women's and children's health being two of the key objectives of the Mission. Another key objective of the NRHM is the mainstreaming of AYUSH Systems (Ayurveda, Yoga & Naturopathy, Unani, Siddha and Homoeopathy) in the health delivery system of the country.





#### **OBJECTIVES OF THE NATIONAL CAMPAIGN**

#### **Primary objectives**

- To sensitize all stake holders, i.e. Policy Makers, Program Evaluators, Opinion Makers, Homoeopathic, Allopathic and other physicians and NGO's regarding the strengths of Homoeopathy in Mother and Child Care
- To provide a platform for exchange and orientation of knowledge among Homoeopathic, Allopathic and other Physicians concerning the scope of Homoeopathy in Mother and Child Care

#### Secondary objectives

- Establish linkage among the Educational/Research Institutions, N.G.O's and the clinicians
  to disseminate the efficacy of Homoeopathy in addressing the health issues pertaining to
  Mother and Child Care
- Promote greater awareness among Homoeopathic, Allopathic and other practitioners in dealing with issues related to Mother and Child Care
- Create avenues for coordination amongst practitioners of different streams of medicine (AYUSH and Allopathic) for promotion of Mother and Child Care, so that certain complicated conditions related to Mother & Child Health could be jointly dealt with
- Involve practitioners of other systems of medicine to convey strengths of Homoeopathy in Mother and Child Care, so that they can advise their patients to avail of the services of Homoeopathy in the conditions where their therapy is contra-indicated or has limitations
- Determine the applicability of community-based participatory approaches for the future development and implementation of a comprehensive Mother and Child health care program using Homoeopathy



#### NATIONAL WORKSHOP ON HOMOEOPATHY FOR HEALTHY MOTHER & HAPPY CHILD



#### An Introduction

In the first phase of the campaign, a National Workshop on "Homoeopathy for Healthy Mother & Happy Child" was organized at India Islamic Cultural Center, New Delhi during 5<sup>th</sup> & 6<sup>th</sup> November, 2007. The workshop was coordinated by the Central Council for Research in Homoeopathy, an autonomous organization of the Department of AYUSH, Ministry of Health & Family Welfare currently Ministry of AYUSH. The workshop was structured to maximize the exposure of the participants to the strengths of Homoeopathy & sensitize them for better policy & program coordination & implementation in order to integrate Homoeopathy at all levels i.e. State & District level with respect to Mother & Child Health Care. This was the beginning of a series of State Level & District Level campaigns proposed for propagating the strengths of Homoeopathy. The workshop aimed at providing a platform for the exchange of information & establishing linkages between the stakeholders so as to carry forward the national campaign.

The participants of the workshop included policy makers, allopathic physicians & homoeopathic physicians. Representation was also seen from homoeopathic pharmaceutical industry, homoeopathic publishers & non-governmental organizations (NGOs) dealing with health care. A total of 292 delegates from India & abroad, including 64 policy makers, 41 allopathic physicians & 163 homoeopathic physicians participated in the workshop. There were 12 representatives of homoeopathic industries & 12 from NGOs from all over India.

The resource persons at the workshop were representatives of these groups of participants. They included homoeopathic physicians from India & abroad, allopathic physicians who further studied Homoeopathy & are practicing Homoeopathy, Policy Makers including

Health Secretaries & Mission Directors of National Rural Health Missions (NRHM) or their representatives.



The introductory session at the workshop was a plenary session, was chaired by Mrs. Anita Das, Secretary, Department of AYUSH who introduced Homoeopathy & its role in Mother & Child Care to the audience. Also, the concept of mainstreaming of AYUSH was introduced to the participants. The breakaway groups on the first day of the workshop gave emphasis on concept clarification & identification of group specific problems and issues. Resolutions were made by individual groups taking into consideration the future role they are expected to play in carrying forward the National Campaign. On the second day of the workshop only plenary sessions were held where the resource persons shared specific success stories with the participants. The plenary sessions resulted in formation of resolutions whilst creating avenues for coordination & future cooperation.

The workshop also aimed to assist the participants in acquisition of practical knowledge that would lend them to the future capacity to replicate this workshop at state & district levels & become active participants in the Mother & Child Health programs in India, through Homoeopathy.

#### **INAGURATION & VALEDICTORY SESSION**

The National Workshop was inaugurated by Hon'ble Union Minister of State for Health & family Welfare, Smt. Panabaka Lakshmi on 5<sup>th</sup> Nov 2007 by garlanding the statue of Dr. CFS Hahnemann & lighting the lamp. Other dignitaries on the dais were Smt. Anita Das, Secretary, Department of AYUSH; Shri Verghese Samuel, Joint Secretary, Department of AYUSH; Dr. Diwan Harish Chand (Guest of Honour) & Prof. Dr. C. Nayak Director, CCRH.

The Valedictory Session on 6<sup>th</sup> November 2007 was graced by the Honourable Union Minister for Health & Family Welfare, Dr. Anbumani Ramadoss as the Chief Guest. He emphasized the need for integrating the various Indian Systems of Medicine & Homoeopathy with the mainstream healthcare delivery in the country. Other dignitaries present on the dais



were Smt. Anita Das, Secretary, Department of AYUSH; Dr. S.P. Singh, Advisor, Homoeopathy, Department of AYUSH; Shri Verghese Samuel, Joint Secretary, Department of AYUSH; Prof. N.K. Ganguly, Director General, ICMR and Prof. Dr. C. Nayak, Director, CCRH.



#### **RELEASE OF PUBLICATIONS ON MOTHER & CHILD CARE**

Specific resource material & literature were prepared for the workshop. The commitment of the Government of India was reflected by the presence of Honourable Union Minister of State for Health and Family Welfare & Union Minister for Health & Family Welfare. On the occasion, three publications related to the National Campaign on Homoeopathy for Mother & Child Care, namely 'Manual on National Workshop on Homoeopathy for Healthy Mother & Happy Child', 'Strategic Development of Homoeopathy for Mother & Child Care' and 'Homoeopathy for Mother and Child Care- An Overview' were released.





#### RELEASE OF HOMOEOPATHIC KIT FOR THE COMPLAINTS OF THE MOTHER & CHILD

During the workshop, Honourable Union Minister for Health & Family Welfare, Dr. Anbumani Ramadoss, Chief Guest released the *Homoeopathic Kit for the complaints of the Mother & Child*. The kit included homoeopathic medicines with their indications in common conditions related to the Mother & Child Health.






#### **RESOLUTIONS / RECOMMENDATIONS OF THE WORKSHOP**

Shri Verghese Samuel, Joint Secretary (AYUSH) presented the following recommendations made in the workshop

- Homoeopathic medicines are effective for certain common diseases and conditions
  relating to the mother and the child where no hospitalization or expensive investigation
  procedures are required and as such, there is a strong case for popularizing and utilizing
  the system at the primary and secondary health care delivery system level.
- 2. A focused and carefully targeted awareness program needs to be organized to inform and educate the public and practitioners of other systems of medicine about the strengths of Homoeopathy in the area of Mother and Child care.
- 3. Financial and technical support for the Information, Education & Communication (IEC) activities should be provided to the State Governments by the Government of India.
- 4. The State Governments must set up more Homoeopathic Indoor and Outdoor treatment facilities in existing allopathic hospitals under the NRHM. Alternatively, the State Governments could obtain funds from the Department of AYUSH under the Centrally Sponsored Scheme (Hospitals and Dispensaries) for the purpose.
- 5. The administrative set up for Homoeopathy in the State Governments requires to be strengthened.
- 6. The Homoeopathic Medical Colleges, NGOs working in the health sector and social service sector should be involved in the campaign.
- 7. There should be a National Task Force under the Department of AYUSH with representatives from the State Governments to plan and coordinate the campaign.
- 8. The Panchayati Raj institutions and Urban Self-government institutions should also be involved in the campaign.
- 9. Simple homoeopathic remedies for common ailments may be included in the School Health Programs.
- 10. A core group should be sent up consisting of experts of Allopathy and Homoeopathy to make recommendations regarding the specific conditions related to Mother and Child care which can safely and effectively be treated by Homeopathy. The core group will also make recommendations regarding the manner in which PHCs and CHCs in the public health care system and CGHS units will provide homoeopathic treatment for mother and child care.
- 11. There is urgent necessity to improve the quality of obstetric care and gyneacological training given in homoeopathic medical colleges. Attachments to allopathic medical colleges for such training may be considered where the number of labor and gyneacological cases is low in homoeopathic medical colleges.
- 12. A CME program for practitioners exclusively on mother and child care should be evolved and implemented at district level.



- 13. A dialogue with the Medical Council of India should be initiated to provide for admission of Homoeopathic graduates in PG courses of Preventive & Social Medicine and Community Medicine.
- 14. To set up Resource centers at central and state level.
- 15. Orientation modules on Homoeopathy for allopathic doctors should be prepared.
- 16. Need and demand outreach models of the kind used by the Dr. M.L. Dhawale Memorial Trust may be adopted in the states.

#### STATE LEVEL WORKSHOP

The workshop was organized by Deppartment of AYUSH, Govt. of Andhra Pradesh on 24-25 March 2008 at the I.I.C.T. Auditorium, Habsiguda, Hyderabad.

Views of Chief Guest, Smt. Panabaka Lakshmi, Hon'ble Union Minister of State for Health & Family Welfare Govt. of India:

- Allopathic doctors use homoeopathic medicines but they don't agree openly
- ➤ In order to stabilize Homoeopathy, evidence based proofs are more important & thus more focus should be laid on this matter
- ➤ All ASHA workers should be given homoeopathic kits
- Press & media people should cooperate in the propagation of the AYUSH system



#### Views of Dr. Vijay Kumar, Commissioner, Dept. of AYUSH

- > Homoeopathy has a better role in primary dentition problems in children than allopathy
- To involve other physicians from allopathic field in propagating homoeopathy
- In order to integrate homoeopathy with mainstream health care system of the country, department can initiate one year PG diploma for practicing allopathic doctors

#### **Technical Activities**

Many different topics of clinical significance were discussed through the course of two-day workshop. Topics like Scope & Limitations of Homoeopathy in Mother & Child Health, Socio-Economic impact on Maternal Health, Homoeopathic First Aid in Mother & Child Health, Scope of Homoeopathy in Paediatric Disorders were discussed with much enthusiasm from the participants. Dr. G.G.K. Narasimham, Principal, JSPS Homoeopathic Medical College, Hyderabad, spoke on the role of Homoeopathy in MCH.

Apart from the government organizations, there were few representations from the non-government organizations as well. For instance, Mrs. Vasupradha Kartik, Counselor & Psychotherapist, Bhiksha Foundation, Hyderabad, spoke on Prevention of disability, a holistic perspective. Mrs. B. Vijay Lakshmi, Central Development Active Computing (CDAC), spoke on Dissemination of Woman & Child Health related information through India Development Gateway portal. In the concluding session, Mrs. Piyush Antony spoke on UNICEF. The workshop ended with an open discussion with the moderators & other participants.

- 1. To conduct the district level workshops for AYUSH physicians & sympathizers of Homoeopathy
- 2. Sensitizing the role of Mother & Child Health in Health Care delivery system at the grass root level by coordinating with N.G.O.'s
- 3. To implement the uniform drug policy in Healthy Mother & Child Care
- 4. To supply Homoeopathic medicines by the way of kits for implementation of Healthy Mother & Happy Child program





# STATE LEVEL WORKSHOP

The Department of AYUSH conducted two days State Level Workshop on 13-14 Feb 2010 at Hotel Babylon. This workshop was an effort to develop the strong roots of convergence and intersectoral coordination among the medical fraternity and utilizing the merits of each system of AYUSH and building a general consensus on the health issues which can be effectively treated by Homeopathy.

# **Objectives of Workshop**

- To create awareness among the Ayurveda / Homoeopathy / Allopathic physicians on efficacy of AYUSH System
- Creating awareness about the strengths of Homeopathy for Maternal and Child health issues

- To provide a platform for exchange and orientation of knowledge concerning the merit and scope of Homoeopathy among the Ayurveda / Unani / Allopathic practitioners
- To discuss the feasibility of integration of Mother and Child health Care in the RCH program
- To train the Homoeopaths on the scope and limitation for Homeopathy in mother and child problems
- To propagate the alternate therapeutic modalities available in the existing health care system

#### STATE LEVEL WORKSHOP


# Resolutions/ Recommendations


- 1. Improvisation by constitutional treatment with Homoeopathy in nutritional deficiencies like anemia which do not improve even with regular supplementation
- 2. Practical training should be given to Homoeopaths working in Government and Private sector in MCH Health domain
- 3. Homoeopathy has been found to be beneficial in the various stages of disease related to Woman/ Mother:
  - Pre-conception conditions
  - > Specific antenatal conditions in first, second & third trimesters
  - Specific conditions in low risk labor
    - Puerperium
- 4. In the child health sector:
  - Integrated Management of Neonatal & Childhood Illnesses (IMNCI)
  - ➤ Introduction of Homoeopathy for School Going children
  - Adolescent Health is an area mainly not covered by any system of medicine unless they have some specific problem
- 5. Awareness about Homoeopathy may be increased through IEC campaigns/ activities at district level.
- 6. ASHA workers need to be sensitized about the Homoeopathic System of Medicine and the first aid ASHA kits should be provided to them.
- 7. Accessibility to homoeopathic health care facilities through cafeteria approach of Delhi Govt/ Co-location of health services. The website inaugurated by Hon'ble Chief Minister www.homeo.delhigovt.nic.in shall further the cause.
- 8. Collaborative research studies with well designed protocols are required to be undertaken for increasing the use of Homoeopathy in MCH.
- 9. Field studies with Homoeopathic interventions should be undertaken. Only such type of studies will be a living document to show the effectiveness of the services provided.



- Homoeopathic medicines are safe during pregnancy and are indicated favorably in various medical problems encountered during pregnancy




- Homoeopathic system of medicine being holistic in nature, cost effect and non-toxic, can be extensively promoted in the rural areas for Mother and Child Care



# STATE LEVEL WORKSHOP





# **Resolutions/ Recommendations**

- 1. To establish the Government Homoeopathic College in the state, to be a model for the other colleges
- 2. Effective treatment of people living in the coastal areas of Gujarat with Homoeopathy. Homoeopathy has a significant role in treating the diseases originating due to different weather conditions in the coastal areas. Hence, proposed to establish a homoeopathic research centre in the state to find out the benefit of the system.
- 3. To recommend the State Govt. to initiate Projects like "Sickle Cell Anemia Control, Awareness & Crisis Management through Homoeopathy" in Aadivasi areas of Gujarat.
- 4. Request the Govt. of India to start at least one Homoeopathic Dispensary in each of the 225 taluka's in Gujarat & thus be able to take Homoeopathy to the most interior of the areas.
- 5. Homoeopathy may be given equal importance in comparison with the treatment methods like Ayurveda etc. with respect to budget, dispensaries, hospitals etc.
- 6. State Government may establish a Homoeopathic Pharmacy in the public sector / Cooperative Sector/PPP mode.
- 7. Propose to State Govt. that it should make a provision for issuing necessary orders to accept the medical certificates and other documents duly signed by the qualified doctor in government, semi government institute, banks etc.
- 8. The State Govt. shall provide necessary grants to establish & maintain Maternal and Child Clinic, Special Wards for institutional deliveries in all Homoeopathic Medical Colleges in Private/Grant-in-Aid Sector in the state.
- 9. The State Govt. should implement the National Campaign on Homoeopathy in Mother and Child care throughout the state through Panchayati Raj institutions
- 10. The State Govt. may establish Homoeopathic Ward in all District Allopathic Hospitals through the NRHM/AYUSH scheme during the plain period



#### **DISTRICT LEVEL PROGRAMS**

One day District Level Orientation Program was held on 15/10/2010 at Kincha Hall, Bharatiya Vidya Bhavan, and Race Course Road, Bangalore. Govt. Homoeopathic Medical College was assigned to conduct the Program at District Level.

- > Second Session- Paediatrics in Homoeopathy and concepts and avenues of referred cases between Different Systems of Medicine




➤ **Third Session**- Prevention and Homoeopathy- First Aid, Health Education and Nutrition in Homoeopathy

The session concluded with a valedictory function with Dy. 



- Role of Homoeopathy in Delivering MCH Services and the Implementing Process of State Campaign on Homoeopathy for Mother and Child Care



- Case of Wilm's tumor in a 3 month old baby completely cured by Homoeopathy
- Research work on Hemophilia
- Case of Patent Ductus Arteriosus A developmental defect in the heart, in a 6 month old baby, managed with Homoeopathy
- Cases of Malaria, Pneumonia & Swine flu managed successfully with Homoeopathy

#### **Resolutions/ Recommendations**

The State Task Force Committee along with the workshop delegates unanimously resolved the following recommendations

- 1. The workshop recommended to the Govt. of Maharashtra that the homoeopathic hospitals attached to the homoeopathic medical colleges should be financially assisted by the State/Central Government to establish Maternal & Pediatric clinics, wards, sterile labor rooms, appointment of full time Obstetrician & Pediatricians and most urgently to fill up the vacant posts of Honorary Homoeopathic Physicians and Houseman with proper Honorarium and to give stipend to the homoeopathic physicians and Registrar of Government Homoeopathic Hospital.
- 2. To request the State Government to rename the Directorate of Ayurveda as "Department of AYUSH" as is there in the Central Government in many states and Homoeopathy may be brought under an independent Director of Homoeopathy as its head with two Dy. Directors, one for Homoeopathic education in Medical education Department and another Dy Director for health care services in Public Health Dept or to amalgamate both the Public Health Dept and the Medical education Dept of Mantralaya under one ministry to implement the Government policies & schemes effectively to reach the common man as quicker as possible.
- 3. To request the Department of AYUSH, Govt. of India to have a special consideration for the state of Maharashtra so that Homoeopathic sector in Maharashtra can be improved. For this purpose the workshop recommended that necessary funds may be provided to the State for:



- a. Opening of homoeopathic ward for paediatric care in all the District & Civil Hospitals in Maharashtra under the supervision of Deputy Director, Homoeopathy
- b. To establish specialty clinics for maternal care in all the District & Civil Hospitals in Maharashtra under the supervision of Deputy Director, Homoeopathy
- c. To open homoeopathic wing in all the PHCs and CHCs.
- 4. The NGO's who are interested to establish Centers of excellence in Homoeopathy through PPP mode and avail the benefit of other schemes such as PHI, Local Health tradition, etc. may be given priority from the State since the qualified Homoeopaths in the state is the highest in the country
- 5. The State Government may establish one Government Homoeopathic Medical College under the Govt. sector to be the model for the private homoeopathic colleges. The Central Government may extend financial assistance for this purpose.









#### STATE LEVEL TRAINING OF TRAINERS PROGRAM

The first five-days State Level Training of Trainers Program was held at Nashik, Maharashtra from 7<sup>th</sup> to 11<sup>th</sup> Dec. 2009. It was organized in the premises of Maharashtra University of Health Sciences, Nashik. The program was inaugurated by Principal of Dapoli Homoeopathic Medical College. The entire event was video recorded for future use at other places.

- Sincere thanks to all those who have attended this graceful program and to those who offered assistance in making this workshop a success


# Views of Dr. Eswara Das, Director, National Institute of Homoeopathy, Kolkata:

- 5. In view of the fact that there is a demand for more qualified Homoeopathic doctors and also as there is no Homoeopathic college in the State, the workshop recommended to the Govt. of India, to allot at least 5 seats every year in National Institute of Homoeopathy, Kolkata for BHMS course and 2 seats In MD (Homoeopathy) course for Mizo students
- 6. Since there is no State law to constitute a regulatory council, Ayurvedic and Homoeopathic Doctor's practicing in the state cannot register themselves as legal practitioner. There is an urgent need to enact laws to constitute Ayurvedic and Homoeopathic Council in order to have ISM&H practitioners registered in the State.

- 3. To request the Department of A YUSH, Govt. of India to have a special consideration for the State of Nagaland so that AYUSH sector in Nagaland can be improved
- 4. In near future maximum programs of AYUSH may also be held in the State of Nagaland
- 5. In view of the fact that there is a high demand for more qualified Homoeopaths in the state, workshop recommended to the Govt. of India to allot at least 5 seats every year in National Institute of Homoeopathy, Kolkata for BHMS course and 2 seats in MD (Homoeopathy) course to students from Nagaland as there is no Homoeopathic College in the state
- 6. Considering the fact that updating and reorientation of physicians are necessary for better patient care, the Homoeopathic physicians from Nagaland may be sent to National Institute of Homoeopathy, Kolkata for in-house Reorientation Programme/CME from time to time. The Director, National Institute of Homoeopathy may be requested to provide the infrastructure and facility for the training.





#### **Technical Activities**



Smt. Vijay Laxmi Bhadu, Chairperson, Punjab State Social Welfare Board put forth some important points in the form of:

- Sanctioning of an amount of Rs. 50.00 lakhs for supply of sterilized sanitary pads for females during menses, & to prevent infections of any sorts
- More homoeopathic dispensaries should be opened under NRHM
- Govt. of Punjab should give employment to homoeopathic doctors, who have devoted 5 years for getting a degree in Homoeopathy three tier workshops at national.

#### **Technical Activities**

Many eminent speakers from Punjab had spoken on various topics related to Mother & Child Health. Dr. D.P. - 4) To strengthen the infrastructure of homoeopathic department of Punjab by opening more homoeopathic dispensaries
- 5) To involve N.G.Os, Local Social Organizations, ASHA Workers and Panchayats in the Mother & Child Care Program
- 6) To involve homoeopathic doctors in the School Health Care Program
- 7) To provide homoeopathic medicines kits for common diseases of Mother & Child to ASHA Workers, for their use in rural and remote areas. ASHA workers should be trained for the use of this Mother & Child Care Kit.
- 8) To provide latest researches done in Homoeopathy to homoeopathic doctors to update their knowledge
- 9) To open Indoor Homoeopathic Hospitals in the State for the diseases of Mother & Child
- 10) To train homoeopaths in Obstetric and Gynecology & then to attach them with Allopathic Hospitals for attaining higher skills.


# Resolutions/ Recommendations Tree tier

The State Workshop adopted the following resolutions unanimously:

- To declare Govt. Homoeopathy Medical College as the State Institute of Excellence in Homoeopathy and request the State Government to take immediate steps to introduce MD (Hom) courses in all disciplines approved by the CCH in the Government Homoeopathic Medical College, Thirumangalam
- 2. To establish a new Government Homoeopathic Medical College at Chennai.

- 3. To organize the district level campaigns in all the 31 districts of Tamil Nadu as a follow up action to keep the campaign a sustainable one. Regular awareness camps on the strengths of Homoeopathy may be organized in rural areas to educate the people about the efficacy of Homoeopathy in Mother and Child Care by involving the ANM workers, Women's self help groups and Community Health workers. The State Resource Centre may provide proper publicity material in local language about homoeopathy and its role. The Department of AYUSH, GOI may provide additional financial support to conduct such programs.
- 4. To educate and orient the rural homoeopathic practitioners for the effective use of homoeopathy in mother and child care by supplying the standard reference material in the subject. The private Homoeopathic Medical Colleges and NGOs may be involved in effective implementation of the program.
- 5. All the Homoeopathic medical colleges may establish special clinics for Maternal and child care in their hospitals.
- 6. Special training and CME programs on Mother and Child care for the practitioners and paramedics may be introduced by Dept. of AYUSH through the State Resource center and the Colleges under Public and Private Sector. Necessary material and support may be provided by the National Institute of Homoeopathy, Kolkata/Central Council for Research in Homoeopathy, New Delhi to create more awareness about this system in Tamil Nadu.
- 7. The teachers in the Obstetrics/Gynaecology department may be given special training in conducting labour and management of Pregnancy through Integrative Medicine Training which would help mainstreaming Homoeopathy in Mother and Child care effectively.
- 8. To request the National Institute of Health and Family Welfare, New Delhi, State Family Welfare Training Institute and National Institute of Homoeopathy, Kolkata to train Homoeopathic doctors on the National Health Programs from time to time. Special practical training programs may be introduced for the teachers of Homoeopathic Colleges on management of pregnancies and labour in reputed allopathic hospitals. Posting of the interns in allopathic hospitals on management of pregnancies may be made compulsory.
- 9. To design and provide proper audio visual and printed materials in local language abut homoeopathy and its role in Mother and Child Health care
- 10. To request the state government particularly the Mission Director to set up more Homoeopathic Indoor and Outdoor treatment facilities under the NRHM in the existing Allopathic hospitals, PHCs/CHCs
- 11. The administrative set up for Homoeopathy in the Directorate of Indian Medicine and Homoeopathy requires to be strengthened by recreating required supporting staff
- 12. The Homoeopathic Medical Colleges, NGOs, working in the health sector and social service sector should be involved in the campaign.
- 13. The Panchayati Raj Institutions and Urban Self-Government Institutions should also be included in the School Health Programs.

- 14. To extend financial assistance to all private Homoeopathic Medical Colleges as both development and maintenance grants for establishing collegiate hospital with a view to provide public health care and for making facilities for efficient clinical training to the students
- 15. Request the Tamil Nadu Dr. MGR Medical University to establish a Department of Homoeopathy under the University by utilizing the Central Grant available under the 11<sup>th</sup> five year plan scheme for the conduct of programs like faculty improvement, curriculum development, development of text books and teaching aids besides research and advance studies in Homoeopathy.
- 16. Request the State Government to revise the fee fixed for the Homoeopathy Degree course rationally and reasonably with a view to facilitate the Management to run the Homoeopathy colleges with the required standards as per the CCH Regulations.
- 17. Request the State Government to take necessary steps for establishing a Homoeopathic Medicine Manufacturing unit with a Drug Testing Lab in the State.
- 18. Request the State Government to take immediate steps to appoint a Drug Controller with necessary administrative setup with a view to maintain the quality control of Homoeopathic Medicines in the State.



#### STATE LEVEL 'TRAINING OF TRAINERS' PROGRAM

The state campaign on Homoeopathy for Mother and Child Care & TOT on Healthy Mother and Happy Child were held at Coimbatore from 19<sup>th</sup> to 23<sup>rd</sup> August, 2010 at Golden Jubilee Auditorium of Tamil Nadu Agricultural University. The five days workshop was inaugurated by the Union State Health Minister, Hon'ble Shri Thiru. M. Gandhiselvan.

#### **Technical Activities**

Total of 25 sessions were held during the five days' program. Each session had taken 45 minutes, hence 18 hours and 45 minutes of total time was utilized in making the participants aware of the conditions related to Mother & Child Care. 25 resource persons had given their

contribution on different subjects through LCD projectors. Senior eminent Homoeopaths, retired Principals of Homoeopathic Medical Colleges and Professors from different colleges had contributed as resource persons. Medical Officers from Govt. dispensaries under NRHM, Homoeopathic Consultants, (Govt. and Private) from Homoeopathic Medical Colleges had participated in the program. The modules were given to every participant 30 days prior to the workshop as per the guidance of CCRH.



# STATE LEVEL WORKSHOP

The workshop on Homoeopathy for Healthy Mother & Happy Child was held during 19th to 20th May 2008 at Pragna Bhavan, Agartala. # **Views of dignitaries**

Hon'ble minister, Smt. Bijita Nath stressed upon the following points:

Homoeopathic hospital may be provided with all facilities of intra-natal delivery along with postnatal care

#### **Technical Activities**

Following topics were discussed over five days time to create awareness & enchance knowledge of the participants. The topics were:


1. Normal Pregnancy & Child Care

- Main emphasis of W.H.O. is on reducing Infant Mortality Rate and Maternal Mortality Rate and improving the health care delivery system
- Main causes of high I.M.R. are diarrhea, pneumonia, septicemia, pulmonary infection, meningitis etc. Deaths due to diarrhea can be checked by O.R.S.

Dr. S.P.S. Bakshi, President, CCH, Govt. of India enthralled the audience by saying that by 2010 the sale of Homoeopathy is going to be about 26 billion dollars in India This speaks about the popularity of Homoeopathy growing at a fast pace.

- 6. To involve Homoeopathic Medical Colleges, NGO's, Gram Panchayats in the National Campaign
- 7. To include basic information about diseases & their homoeopathic treatment in the School Health Scheme so as to create awareness about Homoeopathy
- 8. To set up Primary Homoeopathic Health Centers on the lines of Primary/ Community Health Centers & to be given basic infrastructure on the same guidelines
- 9. To have better facilities/ practical training for students in medical colleges in the diseases of Gynaecology & Obstetrics. For this students should be sent to allopathic hospitals for training purposes.
- 10. To organize Continuing Medical Education Program for homoeopathic doctors on topics related to Mother & Child Care on regular basis
- 11. To promote & create awareness about the role of Homoeopathy by means of electronic & print media
- 12. To establish State Level Resource Centers of Homoeopathy in the state

- 13. To request the State Govt. to recognize the guidelines of homoeopathic treatment given by Dr. M.L. Dhwale Trust
- 14. To motivate the Village Panchayats & Urban Administrative Depts. to promote & contribute to the development of Homeopathy in the state

The program was launched with an aim to sensitize personnel of present health system irrespective of branches, the PRI's and ICDS officers and health workers regarding the strength & efficacy of homoeopathic system of medicine in the field of Mother & Child Care and provide a platform for exchange and orientation of knowledge among physicians of different branches in the districts. Out of 19 districts, the above said 5 were chosen for One Day Orientation Program and thereafter three days Training Program on Homoeopathy for Mother & Child Care.

The training schedule included scientific seminar, case presentation by State Resource Persons and discussion on the implementation of MCH Program at Village Level.

Venue: District Head Quarters

**Total number of participants-** 180; number restricted according to the set up of the districts. Dignitaries, CMOHs, Dy. CMOH's. District Welfare Officer, Swasthya Karmadhakshya (PRIs) BMOHs, all HOMs, HMOs of Panchayat Dispensaries

A **block level training program** was organized after the district program on homoeopathic system of medicine for the ANM for treatment of a few common ailments of mother and children. A total number of 121 Blocks were chosen from the above mentioned districts. Training was held at the Block headquarters.

The main objective of the campaign was to train all ANMs at Gram Panchayats within the Block where GP or a State Homoeopathic Dispensary manned by a HMO existed. Medicine kit containing 25 medicines for first line management as per guidelines of CCRH, Government of India along with sundries were provided from State Headquarters.

Training Module and training materials prepared in Bengali, containing details about common ailments of pregnant mother & children and their homoeopathic management in accordance with the guidelines of CCRH, Govt. of India was distributed from State Headquarters for the purpose.





2. Was the number of Community Awareness Camps assigned sufficient enough to create awareness at grass root levels?




3. Did you feel that the promotion through handouts/posters was effective in communicating the contents & topics related to Mother & Child Health?







# 4. Did the camps deliver a positive outlook & approach on role of Homoeopathy in Mother & Child Care?




5. How was the response of MCH OPD clinic in your area?




6. What was the level of awareness among common people about the role of Homoeopathy in Mother & Child Care?




7. To what extent did Homoeopathy helped in reducing the ailments of Mother & Child?







# 8. Would you recommend continuation of MCH clinics & community camps in future?




# 9. Overall rating for the National Campaign on Homoeopathy for Mother & Child Care?

### 12. What were the high points of National Campaign?

- Misconceptions regarding Homoeopathy could be cleared
- Good number of patients attended the MCH Camps
- > General patients were also attracted to camps & hence were benefitted
- Awareness created about the role of Homoeopathy in diseases of Mother & Child
- Popularity of Homoeopathy increased through the Campaign; patients were treated at their doorsteps
- Benefit of the poor people at large
- > IEC material helped in creating awareness about the role of Homoeopathy
- Campaign conducted in coordination with the local NGO's, PHC's, CHC's
- Safe & easy mode of administration of medicines
- Cost effective & economical

# 13. What were the low points of National Campaign?

- Only 12 camps assigned per year & the venue was not to be repeated.
- Selection of location for camp within a radius of 40 kms is difficult, especially in mountain region
- Since the camp site was far away from Research Center, in few camps, desired number of patients could not attend due to paucity of time
- No proper follow up of camps
- Limitation of conducting camps in the island territories
- Less number of obstetric patients were attracted to the camps
- Lack of staff including doctors at the CCRH Research Centers
- Budget assigned for medicines was less
- Number of Ante-natal cases were very few
- > Tough task to explain about benefits of Homoeopathy to poor, illiterate people
- Lack of laboratory facilities at the camp site
- Lack of skills of homoeopathic doctors in treating obstetric & paediatric cases, which should be strengthened by means of State/ District Level training
- Lack of planning at base level to follow up the cases at the camps
- ➤ Better integrated approach with focus on nutrition as majority of cases dealt were due to malnutrition, vitamin deficiencies & poor hygiene



#### **CONCLUSION**

On basis of the reviews received in the Feedback Proforma, following inferences could be made:

- The purpose of creating awareness about role of Homoeopathy in Mother & Child Care was achieved greatly through Community Awareness Camps & MCH Clinics
- > 57% of the respondents believed that the number of Community Awareness Camps assigned were sufficient enough to create awareness at grass root levels
- ➤ 62% felt that the promotion through handouts/posters was effective in communicating the content & topics related to Mother & Child Health
- A good **89%** of responses indicate that the camps delivered a positive outlook & approach on role of Homoeopathy in Mother & Child Care
- Fairly good response of 91% was received for the MCH OPD Clinics
- ▶ 98% results were in favour of effective treatment with Homeopathy in ailments of Mother & Child
- ➤ A strong & convincing **100%** of the results were those in favour of continuation of the MCH OPD Clinics & Community Awareness Camps
- At the end, **98%** believed the National Campaign on Homoeopathy for Mother & Child Care to be a success

#### **SWOT ANALYSIS**

#### **STRENGTHS**

- Homoeopathic concept to health & approach to health is holistic. It has been described as a multidimensional process involving the well- being of the whole person (mind, body, soul) in the background of his environmental influences. Therefore, all the symptoms are verified & analyzed both at the subjective & objective level.
- ➤ The holistic homoeopathic treatment enables us to correct not only the physio- biochemical disturbances & pathology involved in the disease process, but also to identify & manage the predisposing factors involved in the causation of the disease.
- As homoeopathic treatment is holistic in nature, it can take care of other diseases along with the one dealt thereby improving the overall health status of the individual.
- With the constitutional homoeopathic treatment, we can retard the progress of the disease, & keep the disease under latent state, especially in cases where cure is not possible by both conventional & homoeopathic treatment
- It is a well known fact that those children, who have been on homoeopathic medication since their birth, grow healthier & develop a better immune system
- Numbers of medicines in Materia Medica are immense, & the treatment plan can be tailored to suit each individual patient
- Improvement indices, both subjective & objective, & favorable pathological changes can be appreciated easily with the help of investigations

#### **WEAKNESSES**

- ➤ There has been limited assessment of the efficacy of homoeopathic treatment, especially with respect to the mechanism of action of drugs & to the standardization of intervention plan
- No assurance to the patient regarding the duration of the treatment due to the obstacles in the way of treatment
- ➤ Lack of proper coordination between the Council & State AYUSH authorities



- > Poor follow up of cases seen during the camps or at MCH Clinics
- Quantitative data; no qualitative data
- > Authentication of data questionable
- No thorough assessment of trainers after the training program conducted at state/ district level
- Poor coordination of state level activities in some states

# **OPPORTUNITIES**

- Increase in the number of patients for a better analysis of the effect of the homoeopathic drugs. For this, there should be more referrals from the general OPD of the institution, other hospitals & from peripheral centers.
- Continuation of Community Awareness Camps all across the country to provide basic healthcare through Homoeopathy
- Continuation of district level training programs
- Continuation of the National Campaign as a whole to popularize the homoeopathic system of medicine & to reach more people at grass root levels

#### **THREATS**

Non-cooperation from the State Govts. lead to incomplete Campaign at State/ District Level
