



BUDGET AND EXPENDITURE FLOW



SURVEY, COLLECTION & CULTIVATION OF MEDICINAL PLANTS

Background- Medicinal plants provide around 70% of the ingredients which are used in the preparation of Homoeopathic medicines. As there is no other means to locate the raw medicinal components and the ideal geographic conditions, survey and collecting constitute the core of research efforts. For the purpose of preserving genuine plant source material in fresh condition, the Centre of Medicinal Plants Research in Homoeopathy has been created in Tamil Nadu at Indira Nagar, Emerald Post, Nilgiri District.




Major achievements

- Presently, experimental cultivation is being used to grow 104 plant species (92 foreign and 12 native).
- The Centre has carried out 372 surveys.
- Provided 702 raw drugs to different units and pharmaceuticals for standardisation research.
- To date, 11269 herbarium sheets have been accessed and mounted with their voucher specimen number.

DRUG STANDARDIZATION

Background- One of the Council's most important initiatives is the standardization of drugs. It includes a thorough analysis of the pharmacognostical, physico-chemical and pharmacological profiles of Homoeopathic medications in order to study the many qualitative and quantitative properties of drugs. It also includes studying the gross morphology of the raw drug as well as its macro- and microscopic characteristics.



Process and workflow

Major achievements

The council has undertaken Standardization work of Pharmacognostical studies on 352+14 drugs, physico-chemical studies on 387+21+18(chemo profiling) & pharmacological studies on 151 +29 drugs from plants, minerals, chemical and animal sources. 149 drugs have been studied in all the three aspects. The standards of the drugs worked out by the Council are definite gains and are important for preparation of quality homoeopathic medicines.


- Homoeopathic Pharmacopoeia of India- Revision/Up-gradation- Currently 10 volumes of HPI with 1111 different medications.
- The revision work on 225 out of 334 has been completed.
- The revision work on 50 drugs under OHOS has been completed.
- Study of 50 homoeopathic medicinal herbs for HPTLC ATLAS work.
- Study on 03 homoeopathic medicinal herbs has been completed for HPTLC Atlas-II work.
- Study on 07 homoeopathic medicinal herbs has been completed for Image Atlas work.
- Pre-clinical safety evaluation of 06 MT has been completed.
- DNA barcoding study of 03 drugs is on-going.
- Pharmacognosy Laboratory at DDPRCRI (H), Noida Helps in proper identification/authentication of genuine raw drug from its adulterant form by undertaking macro and microscopic study of raw plant. The parts and powders of the raw plant are used for preparation of Homoeopathic drugs.
- Chemistry Laboratory at DDPRCRI (H) Noida- Ensures purity and quality of drug substance (Plant, Animal and Chemical) as well as finished products used in Homoeopathy.
- DDPRCRI also consists of Zebra fish laboratory; Microbiology and Molecularbiology Laboratory and In-House Pharmacy.
- Animal house at DACRRI, Kolkata is also involved in Drug Standardisation.

DRUG PROVING RESEARCH PROGRAMME (HOMOEOPATHIC PATHOGENETIC TRIAL)

• • • • • •

Background- Drug proving process is unique to Homoeopathy wherein the trials are conducted on healthy human beings following a predefined protocol, elicit the finer symptoms of the drug as compared to the gross toxicological symptoms evident from animal studies. The Central Council for Research in Homoeopathy (CCRH) has undertaken it as a continuing research programme since its inception with its focus on proving of fragmentarily proved drugs and indigenous drugs whose standardization studies (physicochemical and pharmacognostic parameters) has been completed.

The CCRH prepared a Drug Proving Protocol on double blind technique which got published in 1987 in the British Homoeopathic Journal. After analyzing the data over the years, taking positive leads from protocols followed by different international Homoeopathic organizations, a generic protocol was developed in 2014. This protocol is being revised from time to time taking into consideration the ethical aspects, the investigations to be conducted during or after the trial, etc.



Major achievements:

- Till now, CCRH has methodically proved 128 drugs which includes 94 from plant source, 09 from animal source, 22 from chemical source, 01 sarcode and 02 nosode. Out of these 128 drugs, 22 are new and extensively proved by the Council, while 100 partially proved drugs are systematically proved by the Council. There are 06 drugs existing in the literature which were reproved by the Council.
- The Council is conducting the research trials in association with 17 Homoeopathic Medical Colleges and has provided technical support to 02 colleges for conducting Drug Proving Research trials at their institutes.
- In the current year, MoU for providing technical support to Homoeopathic Medical Colleges for conducting Drug proving Research trials has been signed with 02 colleges, namely: Sharda Krishna Homoeopathic Medical College and Hospital, Tamil Nadu and Father Muller Homoeopathic Medical College and Hospital, Karnataka.
- Homoeopathic Pathogenetic Trial (Drug Proving Research) Portal which was launched by Shri Sarbananda Sonowal, Hon'ble Cabinet Minister of Ayush on 10th April 2022 became functional from 31st March 2023. The Portal has gone live on 31st March 2023. The URL of the HPT portal is https://hpt.ccrhindia.in. Till date more than 630 volunteers have registered, records of 385 volunteers scrutinized and 286 have been enrolled as provers. These provers are participating in the drug proving trials on 05 coded drugs at present.



CLINICAL VERIFICATION

Background- It Clinical Verification (CV) refers to the confirmatory and systematic process of observing symptoms that are already recorded in homoeopathic literature as proving symptoms and cured cases. It is the process of internal validation of the basic principles of Homoeopathy, and the results can be used for improving daily practice

The Central Council for Research in Homoeopathy (CCRH) has been conducting clinical verification studies of indigenous, rare and fragmentarily proved drugs since its inception in 1978. Some of these drugs are first proved by CCRH. The primary objective of the study is to clinically verify the symptomatology of the drug as observed during proving or as mentioned in source literature. The secondary objective is to ascertain the clinical symptoms that did not appear during the proving but were improved in the patients after its administration, either completely or partially.



Process and workflow

Major achievements:

- Clinical Verification of symptomatic data of 126 drugs has been conducted so far.
- Thousands of proving symptoms have been verified in over 20,000 study subjects in this flagship programme of the Council.
- The data obtained have been published in the form of the book 'Study of Homoeopathic Medicines through Clinical Verification- A new Perspective', in six volumes containing information on 124 drugs and in about 25 peer-reviewed articles, and 26 articles in the Quarterly Bulletin of CCRH (early years).


The upcoming new CV project is titled 'Clinical Verification of 10 homoeopathic drugs: a multicentric prospective interventional single arm clinical trial' and includes the drugs Benzinum nitricum, Cheiranthus cheiri, Cimetidine, Coleus forskohlii, Cucurbita pepo, Cuscuta reflexa, Iberis amara, Justicia adhatoda Omeprazole and Phyllanthus niruri. Out of these Cimetedine and Omeprazole are tautopathic preparations first introduced by the Council and have the source symptoms extracted exclusively from proving data of the Council.

Future Research in Clinical Verification:

Research programs specialized in specific clinical conditions are being designed to validate drug symptomatology. Development of expert systems and designing treatment algorithms for a specific condition is also needed for comparing the medicines already used for a disease/condition with new medicines taken up in clinical verification research which may help in expanding the Materia Medica knowledge. Rigorous reverification programmes are also needed to validate the wider clinical application of certain rare and lesser-known remedies.


CLINICAL RESEARCH

Background- Clinical Research helps in generating, validating and consolidating scientific evidence (in terms of safety, efficacy and effectiveness) of homoeopathic medications, procedures and treatment regimes. The aim is to carry out evidence-based trials based on modern scientific parameters (double-blinding, objective assessment criteria, statistical analysis, etc) without conflicting with the doctrines of Homoeopathy. More emphasis is laid upon the clinical evaluation of homoeopathic medicines in disease conditions of national health importance, where no curative treatment is available in conventional medicine, endemic diseases in certain parts of the country and the so-called surgical diseases. Being one of the major activities of the Council, Clinical research has traversed a path from prospective observational studies to gold standard randomized controlled studies.



Major achievements:

- To the date, the Council has conducted 238 studies on various diseases, out of which 195 studies are concluded (154 observational studies and 41 randomized clinical trials), 21 studies are withdrawn and currently, 22 studies are ongoing.
- The salient achievements in clinical studies have been in HIV/AIDS, Gastroenteritis, Chronic Sinusitis, Influenza like illness, Benign prostatic hyperplasia, acute haemorrhoids, cervical spondylosis pain management, urolithiasis, acute rhinitis in children, Acute encephalitis syndrome, Covid-19, Acute otitis media, hypertension, thrombocytopenia due to dengue, diabetic neuropathy, diabetic foot ulcer, trigeminal neuralgia, chronic kidney disease, Iron deficiency anemia, GERD etc..
- The Council has published three volumes of Clinical Research Studies Series covering 30 clinical conditions.
- Four volumes of Standard treatment Guidelines published covering 66 clinical conditions.
- The results of the studies are published from time to time in the National and International peer reviewed journals of importance.



FUNDAMENTAL AND COLLABORATIVE RESEARCH

Background- Fundamental and Collaborative research is an integral research arena undertaken by the Council with the vision to undertake evidence-based, inter-disciplinary scientific research on fundamental and basic aspects of homoeopathy by collaborating with other Institutes of Excellence having the required expertise and infrastructure.

Process of Collaborative Research: As a crucial step towards promoting collaborative fundamental research, the council invites proposals from scientists on predetermined priority areas through an Expression of Interest (EOI) and provides guidelines and formats for submitting the research proposals.



{Process and workflow}


Major achievements:

- Undertaken 71 project till date, of which 14 are ongoing. 11 projects are presently in pipeline.
- Publication of 79 research paper in peer-reviewed, national, and international journals on several preclinical studies.
- Diseases prioritized under basic research -Cancer, Hypertension, Diabetes mellitus, Arthritis, Osteoporosis, Cerebral Ischemia, Urolithiasis, Prostatic Hyperplasia; and infectious diseases like - Malaria, Leishmania, Dengue, Tuberculosis, Japanese Encephalitis, HIVand COVID-19.
- Collaborated with AIIMS (New Delhi), AIIMS (Bhubaneswar), ICMRRMRC (Bhubaneswar), CSIR-IMMT (Bhubaneswar), CIRE (Kolkata), ICGEB (New Delhi), Delhi Pharmaceutical Science and Research University (New Delhi), University of Delhi, Bose Institute, (Kolkata), Punjab University (Chandigarh), IIT Bombay, KIIT (Bhubaneswar), Amity University (Noida), JIS University (Kolkata), KGMU (Lucknow), DUVASU (Mathura), IIEST (Shibpur) etc.
- Possession of 01 patent entitled 'A Nosode from a Protozoan of the Genus Plasmodium and the Process of Preparation Thereof'.
- Filed for 07 patents regarding prophylaxis and treatment of Leis mania, Japanese encephalitis, Viral encephalitis, Inflammatory diseases, Tissue regeneration and a new process for potentization of homoeopathic medicines.
- Development of advanced and technically equipped infrastructure of Virology Laboratory at Dr Anjali Chatterjee Regional Research Institute, Kolkata to carry out molecular biological works.
- Establishment of Clinical HIV Laboratory at JSPS Government Homoeopathic Medical College, Hyderabad for benefitting HIV-AIDS patients & associated research.
- Establishment of Dr. Bholanath Chakraborty Memorial Fundamental Research Laboratory at Indian Institute of Engineering Science and Technology (IIEST), Shibpur for undertaking fundamental research in homoeopathy.

EXTRA-MURAL RESEARCH SCHEME OF MINISTRY OF AYUSH

Background- The Extra Mural Research Scheme of Ministry of AYUSH has been merged under the "AYURGYAN Scheme" that is designed to encourage Research and Development (R&D) in priority areas so that the research findings lead to validation of claims and acceptability of the AYUSH system and drugs. The scheme is aimed at developing the opportunity for scientific scrutiny of AYUSH systems for the benefit of users, researchers, practitioners, industries & common people at large.

The outcomes of the scheme are expected to harness the potential of Ayush system of medicine in the interest of public health delivery. The evidence thus generated will help in propagating rational use, clinical application and mainstreaming of Ayush.



Major achievements:


- Till date, under the scheme, 46 studies have been concluded and 6 are on-going and 30 new proposals have been received through Ayush NGO Portal.
- CCRH is providing technical support to projects related to Homoeopathy for implementing of Extra Mural Research under AYURGYAN scheme of the Ministry of Ayush.

EPIDEMIC RESEARCH

Background- Epidemics have been huge burden to the mankind for centuries. Considering the need for finding the intervention to reduce burden of infectious diseases, the Council has undertaken research studies to assess the effectiveness of Homoeopathic medicines for diseases like Dengue, Chikungunya, ILI, HIV, JE, Malaria, COVID-19 etc. Council has also undertaken preclinical studies and have utilized their results for field trials both in public health and clinical settings.

Major achievements:

- Undertaken 46 research studies on various epidemic diseases till date.
- The Council has organized medical relief camps nation wide through its network of 24 units/institutes distributing homoeopathic medicines for prophylactic and treatment purpose in epidemics and infectious diseases.
- With the advent of COVID-19 pandemic, Council has published public health advisories as well as undertaken research studies to assess the effect of homoeopathic medicines in COVID-19.
- · Contributed to the development of 04 guidelines for



Year wise research studies undertaken on epidemic diseases since 2014.

Public Health Advisory and Fact-sheets

- Eupatorium perfoliatum 30C as prophylactic for Dengue and Chikungunya.
- Arsenicum album 30C as prophylactic for Covid-19 and its omicron variant.
- Factsheets of Chikungunya, Dengue, Flu Like illness, Acute Encephalitis, Coronavirus infection to provide information and research undertaken for reference.

Publications

- Council has published 16 articles highlighting the promising results of homoeopathy in diseases like dengue, ILI, chikungunya, Malaria, JE and LF.
- For COVID-19, Council has published 13 articles in the international peer reviewed journals.

Research Studies

- Council has undertaken 07 research studies for Dengue, 05 for ILI, 03 for JE, 02 for Lymphatic filariasis, 02 for Chikungunya, and 01 study for Malaria and HIV each.
- For generating evidence regarding the prophylactic effect of Arsenicum album 30C as well as assess the efficacy of homoeopathic medicine for COVID-19, 25 research studies were undertaken, of which 06 are add on treatment, 15 are prophylactic/observational and 04 are preclinical studies.

LITERARY RESEARCH

The Council has re-initiated 'Literary Research' as one of the core research areas.

The Scope of literary research includes:

- International research of Materia Medica, Organon of Medicine and updating Homoeopathy literature with the help of various study branches like Physiology, Neurophysiology, Biochemistry, Psychology etc.
- Development and validation of basic principles, development of tools etc.
- Development of Homoeopathy in different time periods, geographical areas etc.
- Translating of valuable books, monographs etc. from regional/foreign languages to English
- Contribution of stalwarts
- Preservation of original copies of textbooks
- Study of the theory of Miasms
- Updating the repertories
- Development of e-books

The expert group for Literary Research was constituted and 39 proposals were reviewed on 9-10 Nov. 2022.

DOCUMENTATION AND PUBLICATION

Background- Effective communication channelizes information exchange and spreads awareness on scientific and technical issues among general public, researchers and professionals. The Documentation Section was established with the objective of dissemination of knowledge concerning homoeopathy. Being the mirror of the Council's activities and achievements, the Documentation and Publication section aims to produce all the publications in a presentable, reader friendly language without distorting the actual image of the research work. The work done by the Council in the areas of Drug Standardization, Drug proving, Clinical verification and Clinical research etc. is documented and brought out in the form of various publications for the scientific community and the general public.

The publications of the Council include periodicals and non periodicals:

Periodical Publications

- CCRH Newsletter- CCRH Newsletter is a quarterly publication providing up-to-date information about the conducted activities of Council undertaken in various areas of units, institutes of the Council. During the year 2023, Newsletter Vol. 102, 103, 104, 105were published by the CCRH.

Indian Journal of Research in Homoeopathy- IJRH (ISSN 0974-7168 / 2320-7094) is an internationally acclaimed official quarterly journal of Central Council for Research in Homoeopathy, hosted online by Digital Commons, Elsevier. The content of the journal is and manuscript management system is available at https://ijrh.researchcommons.org/journal/.. Authors world over submit their manuscripts which undergo a double-blind peer review process The abstracts are published in five languages: Hindi, Spanish, French, German, Chinese, to ensure wider readership. The popularity of IJRH is increasing worldwide with visitors frequently visiting the journal website. At present, there are 1300 authors registered with the journal and the reviewers' panel consists of more than 500 reviewers with various specialities. IJRH is indexed with Scopus, and metrics are Cite Score 2022: 1.4, SC Imago Journal Rank: 0.251, Source Normalized Impact: 0.382. It focuses on original research and is an important platform for publishing the research outcomes of various studies conducted by the

Council and outside researchers. Authors from world-over submit their manuscripts at ijrh.researchcommons.org, which undergo a double-blind peer review process to get them published in IJRH. During the reporting period (2023-24), the Council has published following issues: IJRH Vol. 17 No. 2, Vol. 17 No. 3, Vol. 17 No. 4.

- 3. Annual Report- An yearly publication of the Council detailing the administrative and technical updates, the status of the national and international collaborations made by Council, the updates on the prevailing research programs, a view on the accounts and the CAG report all are put forth under this umbrella of Annual Report.
- Books/Magazines: The Council disseminates its research outcomes to researchers and medical/homeopathic fraternity in the form of books. During the period (2023-24),11 books, 01 booklet and 01 souvenir was published by CCRH.

LIBRARY

Introduction- The inception of the Library and Information Centre dates back to 1979 when a small library was set up with a small collection of about five hundred Publications to start primarily to meet the information needs of the Research Scientists of the Council. With the passage of time, the library grew at a fast pace, and, in order to cater to the ever-increasing R&D information needs of the professionals, it systematically and gradually grew as a collection of specialized reading materials such as books, periodicals, reference works, serials in the areas of Homoeopathic Research and Drugs & Pharmaceuticals.

All the back volumes of homeopathic journals are digitized and made available to the research scientist of the Council through Council's website.

CCRH e-Library Consortia: The major contents of the portal are
the databases like Medline, Cochrane Database, BMJ Complete,
and UpToDate Database. The portal allows researchers to
explore and download relevant information from different ecollections. The platform is also powered with a single-click
discovery system to search the latest research articles from all
subscribed and open-access publishers to save their time and
effort.

The Council participates in Health/ Swasthya Melas, Arogya and Exhibitions sponsored by ministry of Ayush, Govt. of India with an aim to promote Homeopathy and create awareness among masses for Homoeopathy. The Council organizes free medical check-up camps and provides homoeopathic consultation and medicine during these melas. The general population visiting these melas is sensitized about the role and scope of Homoeopathy in various disease conditions through pamphlets, handouts, and publications.

PUBLIC HEALTH INITIATIVES

Homoeopathy for Healthy Child Programme- Central Council for Research in Homoeopathy undertook a public health program "Homoeopathy for Healthy Child" from February 2015 to March 2020.

The program aimed to:

- 1. Promote healthy teething through biochemic medicines.
- 2. Provide early homoeopathic management for teething related complaints.
- Create sensitization on oral hygiene for infants and young children.

Under this program more than 1500 ASHA/ANM were trained to provide home based care to children for primary dentition related complains. A medicine kit and training manuals for ASHA were developed. A training manual for homoeopathic physicians was also developed.

Outcome: More than 87000 children benefitted under the program. The data analyzed identified that children in the age group of 6 months to 1 year on regular Calc. Phos. 6x had a lesser number of episodes of diarrhoea and URTI infections.

1. Swasthya Rakshan Programme (2015-2020)

The Council through its 11 Institutes including 02 Central Research Institutes & 09 Regional Research Institutes have conducted Swasthya Rakshan Programme from April 2015-2020. Under the program, 55 villages/ colonies nearby to the institutes were adopted. Outreach activities like Swasthya Rakshan OPD and Parikshan Camps were conducted.

Objective of the program was to provide free homoeopathic treatment, screening, identification of risk factors and early diagnosis of diseases, health promotion, assessment of health status and creating awareness about Homoeopathic system of medicine. The activities undertaken were IEC material, Health Surveys, health camps. Awareness rallies. In 2019-20, no. of camps-1138 and no. of beneficiaries-34039.

Achievement: beneficiaries number overall-500300

During 2020-21, the programme was undertaken in 38 identified villages/ colonies by 08 Institutes of the Council. No of beneficiaries: 141006

2. SC Health Camps Under Schedule Caste Sub-Plan

The objectives of the programme are to provide free health care facilities in rural areas, identification of morbidity profile, assess health care needs through surveys, cross referrals to secondary and tertiary care and create awareness/educate people about the healthy lifestyle through health promotion activities.



3. Integration of AYUSH (Homeopathy along with Yoga) in the National Programme for Prevention and Control of Cancer, Diabetes, Cardiovascular Diseases & Stroke (NPCDCS)


Homoeopathy was integrated in NPCDCS program to utilize the services of the Homoeopathic doctors and yoga experts in Krishna (Andhra Pradesh) and Darjeeling (West Bengal) districts at first instance. Further, it was extended to two more districts from May 2017 i.e., Sambalpur (Odisha) and Nashik (Maharashtra). The programme was concluded in April 2021.

Strategies of Integrated NPCDCS Programme

- Outreach activities: Screening for timely detection of various NCDs at the level of PHC and CHCs/CHNCs/BPHC on regular basis.
- Yoga classes for the general masses at the level of PHC and CHCs on regular basis.
- Advise on diet and lifestyle management.
- Treatment cum follow up of population under homoeopathic treatment alone or as add on to standard care along with therapeutic lifestyle changes.
- A team of homoeopathic doctors, yoga instructors, yoga volunteers along with multitask workers provided health care services to the masses at the ground level and thus help in optimizing the use of scarce resources.

4. Rashtriya Poshan Maah Abhiyaan

It is India's flagship programme to improve nutritional outcomes for children, pregnant women and lactating mothers. It was launched in March 2018, the programme through use of technology, a targeted approach and convergence, strives to reduce the level of stunting, undernutrition, anemia and low birth weight in children, as also, focus on adolescent girls, pregnant women and lactating mothers, thus holistically addressing malnutrition. The Council through its 23 institutes has undertaken activities under the Abhiyaan for promoting health and nutrition. The activities have been undertaken for patients in the OPD and speciality clinics, schools and villages during health camps.

NATIONAL COLLABORATION

National Collaborations with Homoeopathic medical colleges

The program aimed to:

The Council has signed Memorandum of Understanding (MoU) with 77 Homoeopathic medical colleges for collaboration in training & research since 2023.

The vision behind the agreement is to inculcate research aptitude amongst students and faculties by providing technical support for capacity building through training workshops, webinars etc. Wherever feasible, Council also undertakes joint/collaborative research studies with college.

Achievements so far:

- I. CCRH has initiated RISE: Research Interaction for Student Enrichment Enhancement and Encouragement; a webinar series for collaborating colleges wherein structured lectures on various topics of research are being taken. O2 Webinar have been conducted with participants of around 75 colleges including students of all these colleges.

As a step forward in capacity building and encouraging research aptitude among undergraduates, the Council is running schemes for providing scholarships for selected medical undergraduates in Homoeopathy of recognized medical Institutes/Universities.

1. Short-Term Studentship in Homoeopathy (STSH) Program Since its inception, 421 students have been awarded scholarships out of 4212 who registered under the STSH program. For the year 2021-22, 99 students were awarded scholarships out of 724 registrations.

Registration no. increased to 1117 in the year 2022-23 out of which 84 students have been awarded scholarships. Considerable increase in awareness as well as the interest of students to conduct research activity is being witnessed each year as 1505 registrations have been received for the year 2023-24.



A-HMIS is a comprehensive IT platform to effectively manage all functions of healthcare delivery systems and patient care in AYUSH facilities. Real-time patient information is collected on a cloud-based software platform in a usable format primarily aimed at understanding the morbidity pattern of patients visiting the OPD facilities of the Council.

The software has registration, OPD and IPD consultation and Pharmacy modules. After the implementation of A-HMIS in November 2018 in a phased manner, it has been functional in 20 health facilities of the Council where 20,96,298 patients have been registered and 18,19,137 patients have been consulted in the A-HMIS till date.



5. AYUSH Research Portal

Ministry of Ayush has developed the portal for disseminating research information related to all Ayush systems of medicine (Ayurveda, Yoga & Naturopathy, Unani, Siddha and Homoeopathy).

The portal provides collection of good quality research articles published in various peer reviewed and other journals. The information provided is categorized into individual Ayush medical systems against a standard set of medical conditions, based on WHO disease classification ICD-11 and navigation is according to ICPC's (International Classification of Primary

Care) 17 categories.

It permits search of research articles with title, authors, scholars, guide, co-guide, designations, department, institution address, journal, university abstract keywords, body system and disease.

Clinical Research further classified into evidence grade-A, B, C based on general guidelines for methodologies on research and evaluation of traditional medicine published by World Health Organization (WHO).

Pre- Clinical Research : 16804
Drug Research : 10334
Basic and fundamental Research : 7895

The Council has attributed in selection and uploading of 42105 research articles on the said portal, in the form of abstracts and full texts (whenever available free of cost). In case of paid articles, links have been provided to access full text articles.

The portal (accessible through http://ayushportal.nic.in), will create awareness and would provide evidence regarding the researchers conducted by Ayush systems of medicine, thereby generating wider acceptance among Practitioners, Policy Makers, Researchers, Authors, Teachers, Students and General Public Worldwide.

6. Homoeopathic Clinical Case Repository

HCCR is a cloud-based portal launched by CCRH with the url:https: hccr.ccrhindia.in/en/. It is a platform for entering homoeopathic clinical cases through a predefined standardized template and to promote transparent and accurate reporting of clinical cases in Homoeopathy. It aims at providing clinicians, researchers, medical students, patients, regulators and policy makers a starting place to explore content and identify treatment trends, morbidity patterns, improvements in quality of life and assessing cure rates of common and rare clinical conditions using homoeopathic interventions.

The key highlights of the portal include

- Decision workflows and intuitive dashboards provide meaningful tailored insights with data been analysed for specific outcomes parameters.
- Structured data representation.
- Users can access the evidence anytime and further analysis and correlation of data can be done for establishing the efficacy of homoeopathic interventions.
- Interactive visualization and reporting. Use of well-thoughtout structured proformas for data capture with specific outcome parameters identified-like investigations, outcome scales and outcome questionnaires.

PHARMACOVIGILANCE PROGRAM

According to the World Health Organization, pharmacovigilance is the science and activities relating to the detection, assessment, understanding and prevention of adverse events or any other possible drug-related problems. The purpose of the Pharmacovigilance initiative for Ayurveda, Siddha, Unani, and Homoeopathic (ASU&H) drugs is to collect, collate and analyze data to establish evidence for the clinical safety of the ASU&H drugs in a scientific manner for documenting clinical evidence of the safety of these drugs and undertake surveillance of advertisements of these ASU&H drugs.

Ministry of Ayush, Government of India has accordingly initiated the Central Sector Scheme for augmenting quality of Ayush drugs during the 15th Finance Cycle (2021-22 to 2025-26) by merging the existing Central Sector Schemes of Pharmacovigilance, Central Drug Controller of Ayush and Quality Control of ASU and H drugs. This scheme is named as AYUSH OUSHADHI GUNVATTA EVAM UTTPADAN SAMVARDHAN YOJANA (AOGUSY). AOGUSY is one of the schemes that intends to provide the support for quality of Ayush drugs and to achieve specific objectives and outcomes related to promotion of Ayush drug industry and strengthen the regulatory framework.

Central Council for Research in Homoeopathy under AOGUSY Scheme of the Ministry of AYUSH has 9 functioning Peripheral Pharmacovigilance Centers (PPvCs) which are as follows:

- Dr D P Rastogi Regional Research Institute of Homoeopathy, Noida (U.P)
- 2. Regional Research Institute of Homoeopathy, Gudivada (Andhra Pradesh)
- Dr Anjali Chatterjee Regional Research Institute of Homoeopathy, Kolkata (West Bengal)
- 4. National Homoeopathy Research Institute of Mental health, Kottayam (Kerala)
- 5. Regional Research Institute of Homoeopathy, Mumbai (Maharashtra)
- 6. Regional Research Institute of Homoeopathy, Guwahati (Assam)
- 7. Regional Research Institute of Homoeopathy, Agartala (Tripura)

- 8. Regional Research Institute of Homoeopathy, Imphal (Manipur).
- 9. Clinical Research Unit of Homoeopathy, Port Blair (Andaman & Nicobar Island).

A total of 17 Adverse Drug Reactions/ Adverse Drug Events along with 194 misleading advertisements were reported from April 2023 to January 2024 and appropriate actions were taken. Regular distribution of pamphlets and other IEC material to the patients was carried out in order to sensitize them about pharmacovigilance program. The Induction/Training programs/Workshops, Webinars etc. for Pharmacovigilance Centre are regularly attended by the coordinators of Pharmacovigilance Programme at PPvCs.

EVENTS

- 1. World Homoeopathy Day
 - WHD is celebrated all over the world to commemorate the birth anniversary of Dr Samuel Hahnemann on 10th April every year. CCRH has organized a scientific convention on quality research in Homoeopathy on different themes like "Integrating Homoeopathy in healthcare" in 2016; "Enhancing Quality Research in Homoeopathy" in 2017; "Innovative, Evolve, Progress: Exploring Science since 40 years" in 2018; "Sarvajan Swasthya Homoeo-Parivar: One Health One Family" in 2023 etc. These are the ideal opportunities for academicians, scientists, professionals, and researchers of various disciplines to connect and deliberate on various topics related to Homoeopathy. - 2. The First World integrated Medicine Forum (WIMF) on regulations of homoeopathic medicinal products opened on 23rd February 2017 at Hotel Ashok, New Delhi. It aims of bringing the Homoeopathic industry and regulatory sector on a common platform for strategic discussion that this 'World Integrated Medicine Forum on the Regulation of Homoeopathic Medical Products: National and Global strategies', was conceived jointly by Central Council for Research in Homoeopathy, Ministry of Ayush, Govt. of India and by World Integrated Medicine Forum (WIMF), an international firm that organizes, and provides consultation for arranging such fora.
- The Second World integrated Medicine Forum (WIMF) on the regulation of Homoeopathic Medicinal Products with the theme 'Advancing Global Collaboration' was organized by CCRH, with the support of Ministry of Ayush, Homoeopathic Pharmacopoeia Convention of the United States (HPCUS) and European Coalition on Homoeopathic and Anthroposophic Medicinal Products (ECHAMP), Pharmacopoeia Commission of Indian Medicine and Homoeopathy and Central Drugs Standard Control Organisation (CDSCO) at Hotel JW Marriot, Goa from 23rd-25th January 2019.

4. CCRH, an autonomous organization under Ministry of Ayush, Government of India and Homoeoprophylaxis- a Worldwide Choice (HPWWC) a not-for-profit organization working to promote disease prevention and Homoeoprophylaxis jointly organized the 3rd International Conference on Homoeoprophylaxis, "EVIDENCE AND EDUCATION-THE KEYS TO CHANGE" highlighting role of homoeopathic nontoxic alternative to disease prevention.

ACCREDITATIONS

NABH

The Council is committed to providing quality care and ensuring patient safety and is, therefore, striving to get the NABH accreditation/ certification for the hospitals/OPDs at its Units and Institutes.

With this mandate, the Council had undertaken the gap analysis for all the Units/Institutes with respect to the NABH requirements.

To sensitize the Officers and officials of CCRH from all the Units/Institutes on NABH Standards in Homoeopathy, three days training program on implementation were organized in DDPRCRI (H), Noida from 1st to 3rd Aug 2022; RRI (H), Puri from 23rd to 25th Aug 2022; RRI(H), Gudivada from 13th to 15th Sep 2022; NHRIMH, Kottayam from 30th Aug to 1st Sep 2022 and similar training session was held by the Council at Ayush Auditorium, CCRH, New Delhi, from December 5th to 7th, 2022.

The documentation for the Entry Level Standards for Ayush Centre consisting of Standard Operating Procedures for 8 chapters, Apex manual, and Infection Control manual were prepared and shared with all the eligible Units/Institutes to facilitate documentation work.

The documentation has been completed and implemented at 11 Institutes/Units and the application for 01 Institute has been submitted to the NABH. Hospital standards for full accreditation have also been drafted and implemented at DDPRCRI(H), Noida. CRI(H), Jaipur became the first Institute under the Council to obtain NABH Ayush Entry Level Certification on 12th May 2023, followed by RRI(H), Hyderabad on 13th Dec. 2023.

NABL

NABL accreditation for both Clinical (IS/ISO 15189:2022) and Drug Standardization (ISO/IEC17025:2017) Laboratories involves rigorous assessments of the laboratory's technical competence,

quality management system, personnel qualifications, and equipment calibration, thus enhancing the confidence of stakeholders in the accuracy and validity of testing.

The CCRUM had organized 04 one-day NABL Exposure Trainings for Ayush Scientists in each zone. Thereafter, the Council organized "Medical Laboratories Quality Management System and Internal Audit as per IS/ISO 15189:2022" training program at CRI(H), Noida from 7-10 August 2023 and 16-19 December 2023 for the Scientists and Laboratory technicians by National Institute of Training for Standardization, Bureau of Indian Standards, Noida.

Also, the gap analysis for the laboratories was done and action points were suggested. Accordingly, the units/institutes are working to close the gaps and are applying for EQAS for Entry level certification of labs. The SOPs, Manuals, Annexure etc. were drafted and shared with labs to facilitate their documentation process and are being finalized.

The Council has Drug Standardization laboratories at DDPRCRIH, Noida and DACRRIH, Kolkata. TO ensure the quality of laboratory services, the Council provided training to the concerned scientists on "Laboratory Quality Management System & Internal Audit as per IS/ISO/IEC 17025:2017" from 11-14 July 2023 at National Institute of Training for Standardization, Bureau of Indian Standards, Noida.

The Quality Manual, Executive Procedures, SOPs, Formats etc. have been finalized and training is being imparted. The Quality Assurance programme is being ensured.


COUNCIL'S ISO 9001-2015 CERTIFICATION
