4. The aforesaid In-situ promotion shall be governed by the terms and conditions as contained in the Office Memorandum referred to in para 1 above.
5. If there is any change in the status of Non-qualifying Service of the candidates recommended for In-situ promotion on account of retrospective sanction of extraordinary leave on private affairs or on detection of any error in the relevant records or on account of any other reason, the effective date of In-situ promotion will stand altered to the date on which the candidate actually completes the required length of qualifying service.
